THE POSSIBLE PUNISHMENTS FOR THOSE FOUND GUILTY OF RAGGING SHALL BE ANY ONE OR ANY COMBINATION OF THE FOLLOWING

Cancellation of admission

Suspension from attending classes

Withholding/withdrawing scholarship/fellowship and other benefits

Debarring from appearing in any test/examination or other evaluation process Withholding results

Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.

Suspension/expulsion from the hostel

Rustication from the institution for period ranging from 1 to 4 Semesters

Expulsion from the institution and consequent debarring from admission to any other institution.

Fine of Rupees 25,000/-

Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
